7. Changing Role of the CTO

- a. Sharpsteen evaluation need to adopt a rubric from CoSN. This will help give us the credibility needed to bring us in on the conversation before things happen and not after the decision has been made.
- b. Sharpsteen percentage of time spent on what the roles should be of a CTO
- c. Knox-Pipes help find the people in the best role and a leadership role that help them flourish.
- d. Trudell discusses where he has been and how complex it is today.
- e. Couto she has been in the district for 23 years and attends all admin meetings and principals meetings. Communication is key.
- f. Sharpsteen shares that we should look at the Oakland Schools report.
- g. Knox-Pipes need to talk more about TCO.
- h. Couto technology has changed but the administrative thinking has not for the support.
- i. Sharpsteen discuss collaboration, consolidation, etc. It always seems to be the same but we need to find monies that are not part of the general fund. The MiSEN has been helpful because the money is not part of general fund.
- j. Knox-Pipes consortia seems to be better a model. Some issues arise with holding things closely. Need to look at the model and make changes that make sense when times change.
- k. Sharpsteen funding may be used not where it should be and only purchased with bond money.
- I. Knox-Pipes we need to work together
- m. Sharpsteen Future Ready Schools and School Improvement is not the only way to look at this. Need a more holistic view.

8. Kopkau asked about next steps

- a. Knox-Pipes Bring Business Manager and Technology together to talk about funding – frustrations and what are the questions. How do we deal with it? Begin creating a "think tank."
- b. Palme show value creating roles and responsibilities. Updates to the technology page to increase awareness.
