There are problems with the EPC portal in dealing with applications and submissions in a timely manner; the upcoming training sessions on Oct. 31 and Nov. 1; working on possibility of state match for e-Rate; and MDE is working on an updated State Educational Technology plan

Data Hub Presentation

Don Dailey - explained GMEC's concerns about the liability limits of the original data hub district contracts, and so they are negotiating some changes to those, as well as some of the data hub successes at the local district level. Eventually we will see state reporting be done through the data hubs. New capability for districts to use MSDS error checking is coming.

Data Integration: Project Manager – Don Dailey

- ❖ All 5 TRIG Data Hubs are fully functional and 5 of 6 SIS vendors have established the capability to send data to the data hubs, which are the product of the TRIG Data Integration Activity. With this progress, The Michigan Data Hub can now exchange data for over 85% of students and 70% of all districts in the state.
- ❖ **We are asking all districts on eSchoolPlus, MISTAR, PowerSchool, Skyward and Synergy SIS systems to sign up to bring their district on board.** Application information can be found on the TRIG website at <http://22itrig.org/activities/data-integration/districtapplication/>. New functionality available this fall includes dashboards, data quality reports, and the ability to create state reporting extracts. State Education Network (SEN): Project Manager – Dave Childs

- ❖ The SEN is waiting on funding decision from USAC on \$9.4 Million application for E-Rate funding. There are several policy issues under the new E-Rate rules that are not clearly defined, but we feel that we have done everything possible to give the SEN the best chance for an approved funding request.
- ❖ The SEN is beginning to perform **Testing and Acceptance** on individual sites. A successful test means that the SEN is ready to accept data from the ISD's network once the ISD's network is properly configured. Testing and Acceptance has been completed for Dickinson-Iron ISD, Delta Schoolcraft ISD, Marquette Alger RESA, Oakland ISD, Monroe ISD and Saginaw ISD.
- ❖ We will be reaching out to the ISD Technology Directors to ask that information related to routing be provided in the **FACILITIES CHECK LIST**. This will help us manage the routing configuration process.
