ESSER GRANT TIMELINES

- 118Days (September 30)
- Properly Obligate by September 30
- Properly Obligate = MDE Approval
- Please DO NOT Wait until the Last Minute to submit Amendments/Modifications



- 209Days (September 30)
- Fully Liquidate by December 30
- Fully Liquidate= Take Possession
- Please DO NOT Wait until the Last Minute to submit Payment Requests
- If you wait past November 29 to Liquidate, FER will still due 11/29



- Monitoring/Auditing and Late Liquidation
- Third-party vendor is doing financial monitoring (Accenture/GuideHouse).
- Please be timely in responses
- MDE is conducting Programmatic Monitoring (Plans, Use of Funds)
 - June 4 online session Oakland Schools:2pm
- Late Liquidation Option: If you have capital projects or other delays in receipt of items, contact MDE ASAP to get started

- Allowable vs Justified?
- Please know the difference
- LEAs will need to be prepared to address why expenditures were prioritized on some items and not others. MDE approval does not equate to that justification!



 Monitoring/Auditing ESSER I, Equity, and GEER I

Examples subject to justification, you ask?

- Plow Trucks, Passenger Vans, Trailers,
 Recreational Vehicles
- Playground/Sports Equipment and Outdoor Improvements
- Mental Health-aligned expenditures like weight rooms, treadmills, sensory rooms, yoga and massage chairs
- Electronic Signs, PA systems, Auditorium improvements, Expansion of facilities

- 66 (50% 100% remaining) 8%
- **247** (21% 49% remaining) 31%
- **489** (0% 20% remaining) 61%

ARP Section 11t Equalization

- **23** (50% 100% remaining) 11%
- 74 (21% 49% remaining) 36%
- 107 (0% 20% remaining) 53%

Michigan State Grant updates:

Section 18a language

MCL388.1618a:

Sec. 18a. Except as otherwise provided in this article, grant funds awarded and allotted to a district, intermediate district, or other entity, unless otherwise specified in this article, must be expended by the grant recipient before the end of the fiscal year immediately following the fiscal year in which the funds are received. Except as otherwise provided in this article, if a grant recipient does not expend the funds received under this article before the end of the fiscal year in which the

funds are received, the grant recipient shall submit a report to the department not later than November 1 after the fiscal year in which the funds are received indicating whether it expects to expend those funds during the fiscal year in which the report is submitted. Except as otherwise provided in this article, a recipient of a grant shall return any unexpended grant funds to the department in the manner prescribed by the department not later than September 30 after the fiscal year in which the funds are received.
